Misc. Updates:

- o 2014 Budget Analysis. An analysis of the expenditures and revenues for races, programs, and infrastructure has started to look at how the club did and if improvements can be made.
- o 2015 Budget Update The budget process for 2015 is in progress. Race directors and Program directors have been contacted for their 2015 budget inputs.
- o Reviewing key vendors Enterprise, Permits, etc. Permit fees continue to rise and the club will need to add more funds into next year's budget. The club is looking at the various current rental agreements we have to see if we can generate some better terms.

Motion to accept the Treasurer's report: Don moved, Danielle seconded. Carried unanimously,

New Business:

Van Purchase: The club will look at the viability of a van purchase. The club rents over 20 vans every year so we will look at seeing if this makes economic sense. Also the current club van is close to twenty years old and repairs are more frequent.

Race schedule: The club will move the Mathew Henson trail race to Saturday, October 11th so that it does not interfere with the religious holiday of Yom Kippur.

2015 Budget update: Becca has sent requests for budget from race and program directors and others who will need to submit a budget request. There is a deadline of August 22.

Comus 5K: This is the last year for this race. The club will provide ice cream after the race.

Volunteer Picnic/Happy Hour: We will look at finding a place for a happy hour. **Action Item** Don will check for a September 15th location.

IMathlete and financial Access: The board will limit access and do a review of who will need access and of what type. **Action item** Ashley and Don will come up with policy language in October.

Old Business

Background Checks: Ashley will send an email to our program leads with a list of the coaches who are missing the background checks.

2015 Races /Race Survey: Danielle has created a list of potential questions to create a series of polls so the club can get a better idea of what races and programs are liked, disliked, and what improvements can be made to the services the club provides to its members. Action item: Danielle will work on the implementation of the polls

Executive Board Session

Strategic Planning: A discussion about our mission will have an impact on how we allocate resources. **Action Item** Board will review the input from various members and formulate specific points for the future direction of the club.

Review roles & responsibilities: The Board is looking at implementing a transition plan for when the President steps down next year. The first step has been to delegate decision-making responsibility in specific areas to members of the Board so that fewer "day to day" decisions need to be made by the president.

Announcements: The October board meeting will be moved to the 9th due to scheduling conflicts.

The Board will attend the annual Maryland RRCA meeting in Columbia, Maryland, on September 7th. This is a meeting of local running clubs where current trends and club issues are discussed.
